# **Privacy Notice**

## How we use pupil and parent information at St Charles School

#### Why we collect and use this information

We collect and use pupil information for a number for a number of different reasons. The Education Act 1996 and Article 6, Article 9 of the new General Data Protection Regulations (GDPR) laws, provide some of the underpinning purposes for data collection.

Within the school, we use the pupil data:

- to support and monitor pupil learning
- to monitor and report on pupil progress
- to provide appropriate pastoral care
- · to assess the quality of our services
- · to comply with the law regarding data sharing
- to ensure we are providing a safe and secure environment
- for safeguarding and promiting the welfare of children
- to have emergency contacts for each child
- to have accurate medical information on each child.

## The categories of pupil information that we collect, hold and share include (but are not restricted to):

- Personal information (such as name, unique pupil number and address including names and contact details of parents)
- Characteristics (such as ethnicity, language, nationality, country of birth and free school meal eligibility, religion)
- Attendance information (such as sessions attended, number of absences and absence reasons)
- Assessment information
- Relevant medical information
- Special education needs information
- Exclusions and behavioural information
- Safeguarding records
- Photographs and CCTV images.

#### **Collecting pupil information**

Whilst the majority of pupil information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the General Data Protection Regulation, we will inform you whether you are required to provide certain pupil information to us or if you have a choice in this. Where consent is required, the school will provide you with specific and explicit information with regards to the reasons the data is being collected and how the data will be used.

#### Storing pupil data

We hold pupil data for the duration of your child being at this school.

Personal data relating to pupils at St Charles Catholic Primary School and their families is stored in line with the school's GDPR Data Protection Policy.

In accordance with the GDPR, the school does not store personal data indefinitely; data is only stored for as long as is necessary to complete the task for which it was originally collected.

#### Who we share pupil information with

We routinely share pupil information with:

- schools that the pupils attend after leaving us
- our local authority
- the Department for Education (DfE)
- · other educational organisations such as Ofsted
- Local NHS services, including the school nurse
- Family services
- Charities and voluntary organisations
- Survey and research organisations.

## Why we share pupil information

We do not share information about our pupils with anyone without consent unless the law and our policies allow us to do so.

We share pupils' data with the Department for Education (DfE) on a statutory basis. This data sharing underpins school funding and educational attainment policy and monitoring.

We are required to share information about our pupils with our local authority (LA) and the Department for Education (DfE) under section 3 of The Education (Information About Individual Pupils) (England) Regulations 2013.

## Data collection requirements:

#### The National Pupil Database (NPD)

The NPD is owned and managed by the Department for Education and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform independent research, as well as studies commissioned by the Department. It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

We are required by law, to provide information about our pupils to the DfE as part of statutory data collections such as the school census and early years' census. Some of this information is then stored in the NPD. The law that allows this is the Education (Information About Individual Pupils) (England) Regulations 2013.

The department may share information about our pupils from the NPD with third parties who promote the education or well-being of children in England by:

- · conducting research or analysis
- producing statistics
- · providing information, advice or guidance

The Department has robust processes in place to ensure the confidentiality of our data is maintained and there are stringent controls in place regarding access and use of the data. Decisions on whether DfE releases data to third parties are subject to a strict approval process and based on a detailed assessment of:

- who is requesting the data
- the purpose for which it is required
- · the level and sensitivity of data requested: and
- the arrangements in place to store and handle the data

To be granted access to pupil information, organisations must comply with strict terms and conditions covering the confidentiality and handling of the data, security arrangements and retention and use of the data.

### Requesting access to your personal data

Under data protection legislation, parents and pupils have the right to request access to information about them that we hold. To make a request for your personal information, or be given access to your child's educational record, contact the School's Admin Officer.

You also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed;
  and
- claim compensation for damages caused by a breach of the Data Protection regulations.
